**EMS Association/Village 50% Share of Two Life Stat CPR Systems** – President Stene presented the Colfax EMS Association's request for partial Village funding of CPR systems.

Olson to contribute 50% of the cost of one Life Stat CPR System using 2012 WisDOR TRIP revenue received from delinquent Rescue accounts receivable; accept the Colfax EMS Association's donation for the remaining 50% and revisit acquisition of the 2<sup>nd</sup> system in 2013.
