Regular Meeting – January 14, 2013

The January 14, 2013, Village of Colfax Board regular meeting was held at 7:00 p.m. at the Colfax Village Hall. Members present: President Stene, Trustees Halpin, C. Olson, S. Olson, Gunnufson, Schauer and Johnson. Also present were Lawrence Phillips, Jessica Erickson, Travis Borreson, Dan Carlson, Eric Davidson, LeAnne Ralph, Brian Reilly, Rand Bates and Jackie Ponto.

Public Appearances: none.

Consent Agenda – A motion was made by Trustee C. Olson and seconded by Trustee S. Olson to accept items A-D on the consent agenda which were the minutes from December 10, 2012, a training request from Chief Gehring for the WI Leadership Training from February $10-13^{th}$, 2013, a facility rental on March 23, 2013, by the EMS Association for a pancake breakfast, an operator's license from January 14, 2013 through June 30, 2013, and the Mobile Home Park, City View Villa Court license renewal for the year 2013.

Voting for: Trustees Johnson, Schauer, Gunnufson, S. Olson, C. Olson, Halpin, and Stene.

Voting Against: none.

Motion carried.

Communications – Village President - The floodplain meeting is scheduled for Wednesday evening at 6:00 p.m. The Village has already taken a vote on an 80/20 split in the cost of the study with the Village paying 80% and the landowners paying 20% divided by the valuation on the property.

Ordinance 2013-1 Amendment to Permitted Uses in B-1 Downtown Business District - A motion was made by Trustee C. Olson and seconded by Trustee Halpin to approve Ordinance 2013-1 Amendment to Permitted Uses in B-1 Downtown Business District. Trustee C. Olson asked about the types of weapons and Trustee Gunnufson asked about the security that will be in the building. Mr. Phillips informed the Board that he will have hunting equipment including guns and will be installing a security system.

2011 Audit Presentation – Bauman Associates - Eric Davidson started by going over the letters that accompanied the audit and explained that there were adjusting entries that were agreed upon during the audit. There were no significant findings during the audit process. The management letter was reviewed and suggestions were made to properly segregate the workload, but was also noted that with a small office staff that is a hard task. Other suggestions were made and will be considered by management staff.

A motion was made by Trustee S. Olson and seconded by Trustee C. Olson to accept the 2011 audit.

West Central WI Regional Planning Commission – Chris Straight – Went over the September 2012 Power of Ten presentation that was offered to the Village through a grant. The basic idea of the meeting was to go over portions of the Village and discuss what could be done to attract people to the downtown area. The Board discussed some of the items on the list and went over some of the complications that have taken place in the past regarding the Department of Transportation and signage. President Stene would like to revisit some of these issues in another month.

Resolution 2013-1 – Awarding the Sale of \$1,330,000 General Obligation Corporate Purpose Bonds, Series 2013A. Brian Reilly, Ehlers and Associates went over the bids for refinancing the Villages General Obligation debt. Bremer Bank, Menomonie, submitted the lowest bid at 2.1765%. The bid is binding and will be accepted upon the Board's approval. Reilly wanted the Board to know that the amount of bids shows that the Village is in good standing.

A motion was made by Trustee S. Olson and seconded by Trustee Schauer to approve Resolution 2013-1 – Awarding the Sale of \$1,330,000 General Obligation Corporate Purpose Bonds, Series 2013A.

Voting Against: none.

Motion carried.

Snow removal agreement – Colfax Community Fire Department – A motion was made by President Stene and seconded by Trustee Halpin to approve the agreement between

the Village and Fire Department. Administrator-Clerk-Treasurer Ponto will send the signed agreement to the Fire Department for their approval. The agreement is an amendment to original developer's agreement between the Village and the Fire Department to exchange the services of snow maintenance for the filling of water and maintenance of the skating rink.

Voting for: Trustees Halpin, C. Olson, S. Olson, Gunnufson, Schauer, and Stene.

Voting Against: Trustee Johnson.

Motion carried.

Colfax Firefighters – LOSA Payment – A motion was made by Trustee C. Olson and seconded by Trustee S. Olson to approve the LOSA (Length of Service) payment for the Colfax Fire Firefighters. Ponto explained that the Fire Department pays for this benefit, but the Village is the plan sponsor, so the check needs to come from the Village.

Voting for: Trustees Johnson, Schauer, Gunnufson, S. Olson, C. Olson, Halpin and Stene.

Voting Against: none.

Motion carried.

Ordinance Recodification Update – Administrator-Clerk-Treasurer Ponto informed the Board that more investigation needs to be done before a recommendation can be brought before the Board. A motion was made by President Stene and seconded by Trustee C. Olson to table this item for a future date.

Voting for: Trustees Johnson, Schauer, Gunnufson, S. Olson, C. Olson, Halpin and Stene.

Voting Against: none.

Motion carried.

Phosphorous Removal Issue – Travis Hahn was present to discuss with the Board an idea that he engineered for the removal of phosphorous. President Stene asked Hahn to meet with the Administrator to see if his idea was a possibility.

EMS/Police Department Interviews – set date – A date of January 22, 2013, at 6:30 p.m. was set to conduct interviews for a full-time police officer and the part-time EMT/General Laborer.

Ballot Placement Drawing – Administrator-Clerk-Treasurer Ponto placed the names in a hat to determine placement on the ballot for the April 2, 2013 election. The results are as follows:

Village President: Chris Olson, Scott Gunnufson.

Trustee At Large (2 year term): Beverly Schauer, Annie Scheiber, Susan Olson, Chris Olson.

Trustee At Large (1 year term): Scott Gunnufson.

Cemetery Addition Update – Trustee Olson updated the Board on the meeting regarding a meeting with the Colfax Superintendent Yingst. The plan at this time would be that the school would donate two rows of trees as a buffer and then annex the land into the Village. The school is also contemplating annexing the remainder of the land into the Village, but will be brought before the school board for a decision.

Review/Approval Bills – A motion was made by Trustee C. Olson and seconded by Trustee Halpin to approve the bills as presented. Trustee C. Olson mentioned that the bill from Sundstrom's Pit Pumping belongs to the ball field and not the sewer. Administrator-Clerk-Treasurer Ponto will take care of the allocation.
