AGREEMENT FOR AMBULANCE SERVICES

This Agreement is made between the Village of Colfax, a Wisconsin municipality ("Colfax"), and the Village of Wheeler, a Wisconsin municipality ("Wheeler")

- 1. Colfax agrees to provide Advanced Life Support (hereafter ALS) ambulance services, in the common meaning of those words, to Wheeler, whenever called upon to do so for the duration of this Agreement in the geographical area set forth in the attached map.
 - a. Colfax shall promptly respond, upon being notified by the Dunn County Emergency Dispatcher, to any location within Wheeler boundaries marked by the map attached as Exhibit "A", with the ambulance apparatus required by Wisconsin law, as well as sufficient manpower to operate the apparatus, to render emergency medical services at the scene of such emergency.
 - b. Ambulance services shall include both emergency medical care on the scene of an emergency, rendered by emergency medical technicians licensed in Wisconsin as well as transportation by ambulance to an appropriate medical facility by State licensed EMT's. Ambulance services shall include but are not limited to instances involving trauma, medical emergencies, automobile accidents and fire-assisted rescue operations.
 - c. Services may also include mutual aid response by EMS or fire departments from surrounding communities to assist Colfax, should Colfax request aid from such departments. The need for such response shall be in the sole discretion of the Colfax EMS chief or his/her designee. There shall be no additional charge to Wheeler for mutual aid response.
- 2. Where required by Wisconsin law and when advanced life support care is necessary, Colfax agrees to provide State licensed EMT's on each of its ambulance calls to provide ALS care. Colfax agrees to educate and finance the education of all its EMT's and to also finance their continuing education to ensure that they maintain their necessary state licenses. Colfax further agrees to maintain vehicle, property damage, and comprehensive general liability insurance for its vehicles, EMT's, officers, and Colfax as a whole.
- 3. Colfax shall obtain and maintain in full force and effect during the term of this Agreement for the following policies of insurance:
 - a. Workers Compensation policy
 - b General Liability policy with bodily injury, personal injury and property damage.
 - c. Automobile Liability policy for all vehicles with bodily injury and property damage.
 - d. Incidental medical malpractice policy for the rescue and ambulance services provided for in this Agreement.
- 4. In consideration for the above services Colfax and Wheeler agree as follows.

- a. Wheeler, in order to comply with its obligation under WI Statute 61.64 to provide emergency medical ambulance service, agrees to assist in the funding of Colfax through annual per capita user fees for this service. The annual user fee shall reflect, as much as possible, a proportionate amount paid for the actual service provided by Colfax based on the latest population estimates from the Wisconsin Department of Administration Demographic Services Center within the contracted area of Wheeler.
- b. The annual user fee shall be based upon the budget submitted by the EMS chief to the Public Safety Committee of Colfax. This budget shall consider the capital needs of the department for improvement, salaries, fuel, maintenance and supplies, equipment purchase or replacement, training, and in-service. The budget and accounting records of the department are available through the Colfax Clerk at the Village Hall, Colfax, Wisconsin.
- The original per capita user fee for the year 2008 has been established at \$11.78 per capita. Because this Agreement commences March 1, 2008, Colfax shall receive 5/6 of this per capita user fee or a total of \$9.82 per capita for the year 2008. Any change in the per capita user fee for each subsequent year will be sent to Wheeler by September 15th for purposes of budgeting. Wheeler has the right to withdraw from participation by means of a notice of such sent by certified letter to be received by Colfax on or before October 15th following the September 15th deadline for notification of any actual change in per capita user fee. Such withdrawal shall take effect as of December 31st of the year following the October 15th notice deadline. By means of illustration, a withdrawal notice delivered to Colfax on October 14, 2008, would result in the withdrawal of Wheeler being effective as of December 31, 2009. The per capita user fee for the current year shall remain due and payable by Wheeler as provided herein.
- d. Wheeler agrees to pay Colfax the initial per capita user fee by March 1, 2008, and by March 1 of each year thereafter that the Agreement is in effect. If the payment is not made within sixty (60) days after the March 1 due date, a ten percent (10%) penalty will be applied. Colfax shall also have the right to seek payment by resorting to court action if necessary. If court action is necessary to collect the per capita user fee, Wheeler shall be responsible for paying all of Colfax's court fees and other costs, including reasonable attorney fees, associated with such collection efforts.
- e. Unless terminated pursuant to agreement between the parties, Wheeler also agrees that it will not contract with other public or private ambulance companies for ambulance services within the boundaries specified on the map attached as Exhibit "A" for the term of this Agreement. Such term shall begin March 1, 2008, and shall automatically renew on January 1, 2010, for successive two-year periods until terminated according to this Agreement.
- f. In addition to the per capita user fee, Colfax may charge individual patients for service. The individual charges will include mileage, supplies, procedures, and a base fee.
- g. On or before October 31st of each year, Colfax may send notice, by certified letter, of its intent not to renew this Agreement. Any such notice of non-renewal would take effect on the December 31st of the year following the notice of non-renewal. By means of illustration, a non-renewal notice delivered to a participating municipality on October 14, 2008, would result in the termination of the Agreement effective as of December 31, 2009.
- 5. This Agreement may only be modified by means of a written agreement signed by Colfax and Wheeler.


